<b>How to enter</b>	To automatically enter the Promotion, an Eligible entrant must purchase a new Eligible Policy through NPBS during the Promotion period. Entrants receive one entry for each new Eligible Policy. An Eligible Policy is: <ul style="list-style-type: none"> <li>– Either an: <ul style="list-style-type: none"> <li>– Allianz Home and Contents Insurance (Buildings and/or Contents for a single insured address); or</li> <li>– Allianz Landlord Insurance (Buildings and/or Contents for a single insured address); or</li> <li>– Allianz Comprehensive Motor Insurance; and</li> </ul> </li> <li>– That is not lapsed or cancelled at the time of the prize draw; and</li> <li>– Either full payment of the annual policy premium or the first monthly instalment premium has been received by the Issuer, at the time of the Prize draw.</li> </ul> <p>The Eligible Policy will be deemed purchased as at the policy start date.</p>
