

Newcastle Permanent Building Society - Our Kids Day Out Colouring Competition 2021 Terms and Conditions

1. Information on how to enter and prizes form part of these conditions. By participating, entrants acknowledge having read and understood these conditions and agree to be bound by these conditions. Entries must comply with these conditions to be valid.
2. The Promoter is Newcastle Permanent Building Society Limited ("NPBS") ACN 087 651 992, 307 King Street, Newcastle West NSW 2302, phone 13 19 87.
3. Entry is open to residents of New South Wales who are 12 years and under. Employees and their immediate families of NPBS and its agencies associated with this competition are ineligible to enter.
