

Newcastle Permanent Organisational Culture Roadmap (formerly People and Culture roadmap) is continually evolving and now has seven (7) key focus areas. Inclusion and Diversity remains one (1) of these key areas and as reported in our 2017/18 report, there were two initiatives in progress to address gender equality in the workplace: the implementation of Unconscious Bias training, and the introduction of a Women in Leadership/Networking group. Phase 1 of the Unconscious Bias training has been rolled out as part of our Talent identification and development program, and we are currently scoping Phase 2. Our Women in Leadership initiative is also underway with two (2) networking functions held during the reporting period.

Whilst Newcastle Permanent does have policies in place to support gender equality, we recognise that the policies could be further strengthened to highlight our strategies and practices. All policies are reviewed on an annual basis and the process for each review moving forward will include a specific gender equality analysis.
