



Newcastle Permanent Building Society Passbook Conversion Promotion – Your chance to WIN \$1,000 a week during the month of February Terms and Conditions

1. Information on how to enter and prizes form part of these conditions. By participating, entrants acknowledge having read and understood these conditions and agree to be bound by these conditions. Entries must comply with these conditions to be valid.
2. Entry is open only to members of Newcastle Permanent Building Society Limited (“Newcastle Permanent” or “Promoter”) who are residents of New South Wales and are 18 years or over. Entrants must be the Account Owner(s) of a current Newcastle Permanent passbook account prior to the commencement of the Offer Period.
