### 1. About Foreign Currency and International Services

A range of foreign currency and international services are available to our deposit account holders: Foreign Currency Cash, Pre-Paid Travel Cards, Telegraphic Transfers, Foreign Currency Drafts and Foreign Currency Document.

### 2. Key features

Below we set out the key features of our Foreign Currency and International Services.

- 2.1 Foreign Currency – foreign currency cash issued, foreign currency cashed, pre-paid travel cards provided.
- 2.2 Telegraphic Transfers – outward.
- 2.3 Foreign Currency Drafts – issued.
- 2.4 Foreign Currency Document – repurchase.

It is at our discretion whether we will provide these services to you at any time.

### 3. Fees and charges

Foreign Currency Fee (cash)	1% min. \$2	Fee payable when we arrange to cash foreign currency for you. Fee is debited from amount cashed prior to crediting the balance to your deposit account held with us. It is calculated as a percentage of the total Australian value of the currency cashed.
Initial & Reload Pre-Paid Travel Card Fee	0 min. Maximum 1.1% subject to a min. \$15	Fee payable when we arrange for the purchase or reload of a Cash Passport™ Platinum or reload of an existing Multi-Currency Cash Passport™ for you. Fee is included in total amount debited from your deposit account held with us. It is calculated as a percentage of the total Australian value of the amount loaded onto the card.
Telegraphic Transfer Trace Fee	At cost – will be advised to you at time of trace	Fee payable if you request a trace on a telegraphic transfer and the funds are located in the correct account as per telegraphic transfer order.
Telegraphic Transfer Fee (outward)	*\$30 foreign currency **\$50 Australian dollar	Fee payable when we arrange for funds to be sent overseas by you. Fee is inclusive of *\$20 or **\$40 fee charged by Western Union Business Solutions (Australia) Pty Ltd (as applicable). Fee is charged at the time of your request and is included in total amount debited to your deposit account held with us.
Foreign Currency Draft	*\$15	Fee payable when we produce an overseas draft for you, in a currency appropriate for that country. *Fee is inclusive of \$7.50 charged by Western Union Business Solutions (Australia) Pty Ltd. Fee is charged at the time of your request and is included in total amount debited to your deposit account held with us.
Foreign Currency Fee (issued)	1% of the currency amount min. \$5	Fee payable when we arrange for the purchase of foreign currency for you. Fee is included in total amount debited to your deposit account held with us. It is calculated as a percentage of the total Australian value of the currency amount.
Foreign Currency Document Repurchase Fee	Min. \$2 or 1% whichever is the greater of Australian equivalent	Fee payable when we arrange for the repurchase of a foreign currency document. Fee is debited prior to the funds being credited to your deposit account held with us. It is calculated as a percentage of the total Australian value of the currency amount.

Additional fees charged by third parties may also apply. Where applicable these will be set out in the relevant Product Disclosure Statement.

### 4. Changes

Fees and charges set out in section 3 may be changed at our absolute discretion at any time, to the extent permitted by and subject to the requirements of any law that regulates that change. A minimum of 20 days notice by advertisement in a major daily newspaper will be given for any increase in these fees and charges.
